IS YOUR COMMUNITY A QUALIFIED DONEE?

As a qualified donee, you are eligible to issue official donation receipts, receive gifts from registered charities, and receive funding from government programs reserved for qualified donees.

First Nations are considered a Qualified Donee if they constitute a "public body performing a function of government." A function of government generally means any activity or group of activities undertaken to meet a governance role or purpose within a geographic area.

In a First Nations context, a public body is generally an Indian band as defined in the Indian Act with procedures to elect Chief and council or other Aboriginal governments with election procedures.

To be recognized as qualified donees, municipal and public bodies must apply for registration and be added to a list maintained by the Canadian Revenue Agency (CRA).

FIRST NATIONS GUARDIAN INITIATIVE

The **First Nations guardians initiative** is a pilot program which funds First Nations communities to exercise their rights and responsibilities to the land, waters, and ice of their traditional territories through on-the-ground, community-based stewardship initiatives.

The national call for proposals for new **Tier 1** First Nations Guardians' Initiatives is now open. Tier 1 is for **new initiatives**. Previous applicants to Tier 1 can reapply, but funding in one year is not a guarantee of funding in a subsequent year.

The following criteria is used to select projects:

- Clarity of proposal
- Governance
 - Capacity
- Cultural Inclusion
- Community support and engagement
 - Partnership

Details: Maximum allocation \$60,000 per year for activities completed by March 31, 2021.

Application deadline: The deadline to apply for Tier 1 projects is January 10, 2020
