FARM TO SCHOOL CANADA

The Farm to School Canada Program aims to see an improvement in nourishment in schools all across Canada and will promote partnerships across communities where they will then engage in learning about, growing, harvesting, cooking, and eating local and sustainable foods at schools. These grants are delivered directly to schools and the program is open to all schools across Canada from kindergarten to Grade 12. This fund will bring more of the local harvest into schools where it will be featured in a Salad Bar meal service using the Farm to School Approach.

Eligible activities for this program include:

- Capacity building
- Equipment and space modifications,;
- and initial food costs

Funding will be awarded by May 2020. Each school could be awarded up to 100% of project costs to a maximum of \$10,000.

Applications are due **March 27**, **2020**.
