Our January client profile is Stswecem'c Xgat'tem First Nation!

Located on the Fraser River, BC, Stswecem'c Xgat'tem First Nation (SXFN) was formally two distinct bands: Canoe Creek and Dog Creek. In the late 19th century the two lower Fraser River bands joined together as Stswecem'c Xgat'tem First Nation. Today, they honor their separate histories while they have together become a politically self-sustaining Secwepemc community with 745 registered Members.

Stswecem'c Xgat'tem First Nation Members live in their Secwepemc culture and traditions within the beautiful landscape of their traditional territory. SXFN has an elected Chief and Council which consists of

Chief Patrick Harry and five councilors.
