A letter from Nelson: *Why I chose Strategies North*

I first met the Strategies North team when I was working for a First Nation development Corporation as their CEO and we hired SN to do some proposal writing for us. I was involved in



some really exciting projects, but the uniqueness was I was putting people first and money second. It's hard to build a First Nation without including First Nation citizens. The idea was to include as many citizens as possible, this way they can be a part of something instead of watching from the sidelines. Our other unique approach was to target citizens that were unemployed and or on social assistance. At the time I didn't notice that, in my opinion, that's how Strategies North was already looking at projects, their focus was First Nation citizens as well. I spoke with Grant on numerous occasions about work I was doing and the issues I was having; he was, and continues to be a great ear. Anna's Chocolate Zucchini Cake

Ingredients For Cake:

2 cups all-purpose flour (I substitute 1 cup almond flour and 1 cup gluten free)

3/4 cup unsweetened natural cocoa powder

2 tsp baking soda

1/2 tsp baking powder

1 tsp espresso powder (optional) 1/2 tsp salt

1 cup canola, vegetable, or avocado oil

1 cup granulated sugar (l reduce by a third)

3/4 cup packed light or dark brown sugar

4 large eggs, at room temp

1/3 cup sour cream or plain yogurt, at room temp

2 tsp pure vanilla extract

3 cups shredded zucchini

1 cup semi-sweet chocolate chips

Ingredients For Icing:

1.25 cups (2.5 sticks) unsalted butter, softened
3-4 cups confectioners' sugar
3/4 cup unsweetened cocoa powder
3-5 tbsp heavy cream, at room temp
1/4 tsp salt
1 tsp pure vanilla extract
optional for decoration: semi-sweet
chocolate chips

Directions:

Preheat oven to 350°F (177°C). Grease two 9×2 inch cake pans (deep dish style). Set aside.

Whisk the

flour, cocoa powder, baking soda, baking powder, espresso powder, and salt together in a large bowl. In another large bowl using a mixer fitted with a paddle or whisk attachment, beat the oil, granulated sugar, brown sugar, eggs, sour cream, vanilla, and zucchini together until combined. Pour into dry ingredients and beat on medium speed until completely combined. Beat in the chocolate chips. Batter will be slightly thick.

Pour batter evenly into cake pans. Bake for around 25-32 minutes or until the cakes are baked through. Allow cakes to cool completely in the pans set on a wire rack before frosting.

Level cooled cakes if domed. On your serving plate, evenly cover the top of 1 cake with frosting. Top with 2nd layer and spread remaining frosting all over the top and sides. Garnish with chocolate chips.

Store at room temperature for 2-3 days or in the refrigerator for up to 5 days.
